- Electronic and secure transfer of student data between HEIs
- Field trial between Denmark, Finland, Italy, Norway, (Poland), Sweden,
- +400 students in field trial

# EMREX as a building block

- EMREX is about electronic transfer of achievement data by the student/citizen
- Types of use cases
  - Student mobility programs, joint degrees, etc
  - Admission services
  - Recruitment solutions
  - Credential evaluations
- Also other types of achievement records
  - ELMO-standard used also by other services/projects
  - Support for 2<sup>nd</sup> level records
  - Informal, non-formal learning
  - Diploma supplement?
- GDPR “compliant”, the student can transfer his results to be used as chosen by the student

# Roadmap to automatic recognition



ERASMUS+

- Strong political push for mobility and automatic recognition
- Free flowing data is easy – understanding the data is difficult
- In EU Bologna process and ECTS, but still differences
  - Minimum set of data and standard data format needed – and conversion to other standards
- What about grade, degree, level, program conversions?
- Who to trust? Is an HEI always an HEI?
- Who owns the data? Student or HEI?
- How to access data after graduation?
- Paper vs electronic signatures and data. Is legislation an issue or not?

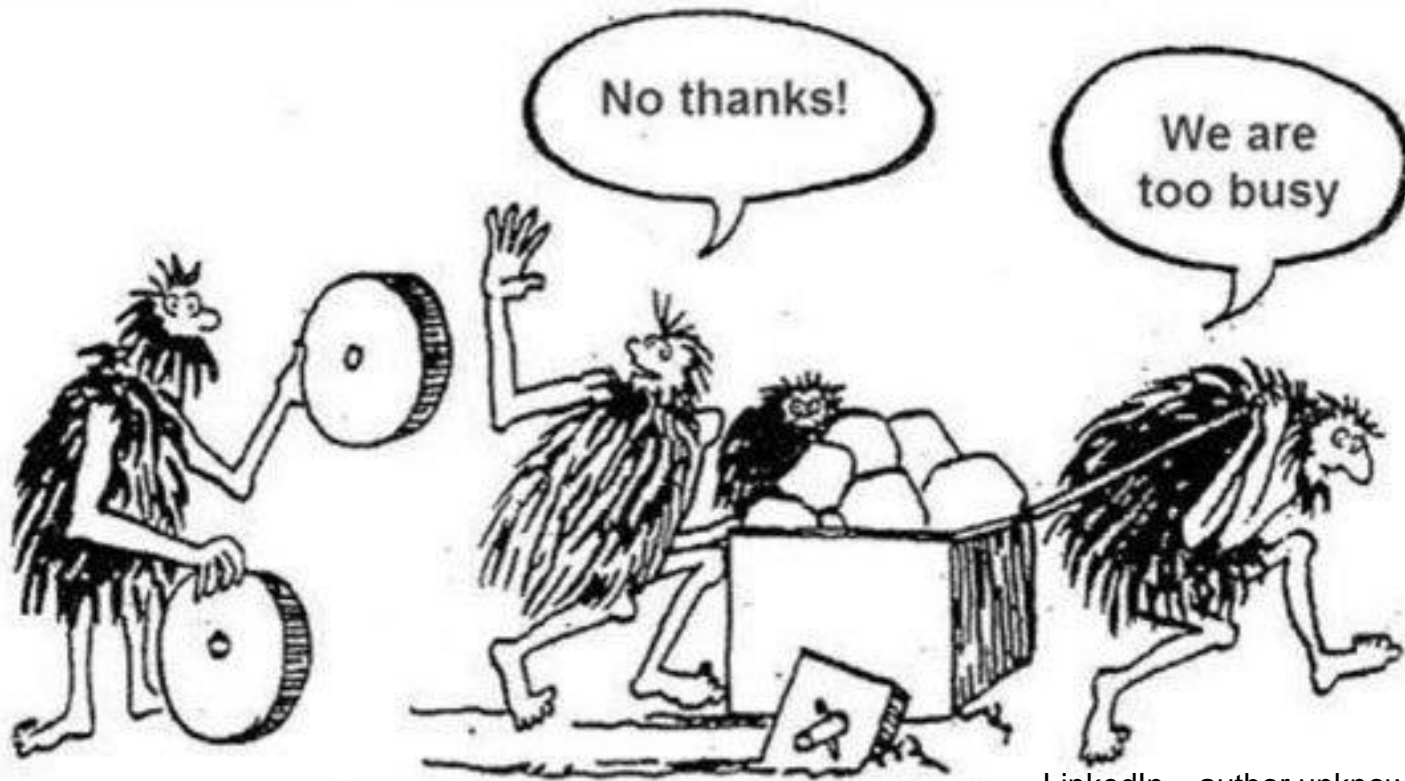
